VI. Tuition Payment Policies

- A. A fee schedule is available through the school office with current rates. Registration fees are non-refundable.

- C. The first tuition payment is due June 1. If payment is not received within ten days, your child will automatically be withdrawn. Subsequent tuition payments are due on the 20th of each month. Payments not made by the 20th of the month are delinquent. After a seven-day grace period, a late charge will be added.
- D. When an account is more than 30 days past due, your child will NOT be allowed to return to school until the balance is paid.
- E. Special tuition arrangements must be made with the Headmaster, and outstanding accounts are reported to the Board of Education.

VII. Parent's or Legal Guardian's Statement

In the event my child becomes ill or is injured while under school supervision, I approve the school authorities to take the following steps:

1. Contact a parent of the student and follow his instructions.
2. In the event neither parent can be reached, contact the emergency numbers given to the school by the parent; secondly, the physician.
3. If the student's physician cannot be reached, the school authorities will use their own discretion in contacting a properly licensed physician and following his instructions.

If, in the opinion of a properly licensed and practicing physician, my child needs medical or surgical services which require my consent before being supplied and I cannot be reached, I hereby authorize, appoint and empower the Headmaster, or designee, to furnish on my behalf oral or written authorization as may be so required. Further, I release the Headmaster, or designee, the school and Spanish River Presbyterian Church from any liability which may arise from the giving of such authorization. It is my desire that my child be furnished with such medical and/or surgical services as soon as possible after the need arises. I also agree to accept responsibility for the cost of the above medical services.
